Re: Application for Alcoholic Beverages License Class H(M)(BWL)(ENT)(S) (the "Application") for that certain premises commonly known as 700 Mill Creek Road, Arnold, MD 21012 (the "Premises")

To whom it may concern:

My client, The Point Crab House and Grill ("The Point"), respectfully submits the above referenced Application. As of the date of this letter, The Point currently holds an Alcoholic Beverage License Class H(M)(BWL)(ENT)(S) (the "License") with the following restrictions: (1) Entertainment License for multiple TV Privilege only (the "Entertainment Restriction"); and (2) All alcoholic beverages must be served with the conjunction of a meal (the "Service Restriction" and the Entertainment Restriction and the Service Restriction collectively referred to herein as, the "Restrictions"). The Point is submitting this Application to have the Restrictions removed for various reasons to be presented to the Board, including, but not limited to, the following.

The Entertainment Restriction has been placed on the License in error. Per inspector Jim Ford's email dated August 2, 2023 (attached hereto), the minutes from the original granting of the License indicate that The Point was originally granted the ability to have two (2) non-amplified musicians. It is unclear why, but at some point this was removed from the License. In a few of the attached Outdoor Service Letters, this ability is referenced along with a noise level limit of 65 decibels. My client is seeking to have this added back to the license with one change. The Point would like to be able to connect the two musicians to the restaurant's speaker system. The Point has provided its customers with live music in this fashion for the last 11 years. It is imperative that The Point be able to hook the musicians up to their speaker system because without it, the music cannot be heard throughout the restaurant without playing at excessive noise levels and by being hooked up to the speaker system, The Point can distribute the music throughout the restaurant and ensure that noise levels remain beneath the State's noise level of 65 decibels.

The Service Restriction is unduly burdensome to The Point's business and does not accomplish the goal in which it was placed on the License in the first place. The Point understands that this restriction was placed on the License to ensure that the restaurant would not be a loud and disruptive bar. Over the last 11

years, The Point has proven to be quite the opposite. Patrons come to The Point largely for their food and family atmosphere. The Point will submit to the Board sales records reflecting a food to alcohol ratio which directly reflects this. In fact, The Point's food to alcohol ratio is much more food centric than similarly situated restaurants. The enforcement of the Service Restriction greatly impairs The Point's ability to effectively run their business for many reasons. Many patrons order alcoholic beverages while they wait for their tables and the restaurant's staff is frankly unable to police this restriction. From a practical standpoint, patrons could sit down, order an alcoholic beverage, and then decide to not order food and leave. The owners of the Point will share with the Board in more detail the practical difficulties of this restriction and why its further enforcement will endanger their business.

Ultimately, The Point has proven over the last 11 years that it is not only a favorite of many residents of Anne Arundel County, but that it is a restaurant committed to serving good food. It has never been and never will be the intent of The Point to be a bar. We kindly ask that you consider this Application and the practical difficulties that the Restrictions placed on The Point create.
