LICENSE REQUESTED: NEW Class B (Restaurant) (Beer/Wine/Liquor) On and Off-Sale, Growler, Crowler, Dancing and Sunday License with Outdoor Dining

This Office finds that the subject property is zoned W1 - Industrial Park District and is located within a stand-alone building. The W1 - Industrial Park District allows alcoholic beverage uses as accessory to other uses. In this case the proposed alcoholic beverage use would be accessory to the principal use of the site as a restaurant and craft brewery.¹

Upon review of the subject application, this Office finds that the proposed use meets the conditional use requirements for alcoholic beverage uses under Section 18-10-104 of the Code as well as the general requirements for alcoholic beverage licenses under 18-2-109. Accordingly, this Office would have **no objection** to the issuance of the requested liquor license.

The applicant is advised that building and/or grading permits are required for all renovation and/or new construction. Additionally, a Zoning Certificate of Use is required for the subject use.

¹ The site plan included with the submission refers to a 'Brewery'. As defined by the Zoning Code a Brewery would not be a permitted use in the W1 District. However, through email correspondence it has been determined that the business will be a Craft Brewery which is a permitted use in the W1 District. The applicant is pursuing the appropriate State license for a Craft Brewery. It is suggested that any future site plans, particularly for Development or Zoning be clear that this is a Craft Brewery vs. a Brewery.


