LICENSE REQUESTED: Class D (Beer/Wine/Liquor) Entertainment, Sunday and Outdoor Dining License

The subject property is zoned C3 – General Commercial District and is located in a stand-alone building. The proposed use is a tavern. Section 18-5-102 of the Anne Arundel County Zoning Ordinance allows taverns by right and allows alcoholic beverage uses as accessory to other uses as a conditional use in the C3 District.

Upon review of the subject application, this Office finds that the proposed use meets the conditional use requirements for alcoholic beverage uses under Section 18-10-104 of the Code as well as the general requirements for alcoholic beverage licenses under 18-2-109. The applicant has provided an exhibit that shows the entertainment area 100 feet or greater from nearby residentially zoned properties. Accordingly, this Office would have **no objection** to the issuance of the requested removal of the restriction of multiple TV's only on the existing liquor license.

The applicant is advised that building permits and grading permits are required for all renovation and/or new construction. Additionally, a Zoning Certificate of Use is required for the subject use.

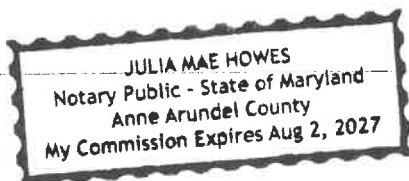
