LICENSE REQUESTED: UPGRADE for a CLASS BLX (Deluxe Restaurant) (On Sale)

(Beer/Wine/Liquor) Entertainment and Sunday License

This Office finds that the subject property is zoned C3 – General Commercial District. The license is for a restaurant that will be a stand-alone building within the Southdale Center shopping center. The C3 District allows a restaurant as a permitted use, and alcoholic beverage uses as accessory to other uses is allowed as a conditional use. As such, the proposed alcoholic beverage use would be accessory to the principal use of the site as a restaurant.

This Office further finds that the proposed use meets the applicable requirements of §18-2-109 and §18-10-104 of the Code with respect to vehicular access and existing traffic patterns for surrounding uses as this is an existing restaurant in the C3 – General Commercial District. Impact to residential areas, existing and allowed land uses, and the magnitude of the activity would also be substantially the same as existing conditions. Accordingly, this Office would have **no objection** to the issuance of the requested liquor license.

The applicant should be advised that building permits and grading permits are required for all renovation and/or new construction. Additionally, a Zoning Certificate of Use is required for the subject use.
