The subject property is zoned C1 – Local Commercial District and is proposed to be used as a tavern. §18-5-102 of the Anne Arundel County Zoning Ordinance allows alcoholic beverage uses as accessory to other uses as a conditional use in a C1 District. As such, the proposed alcoholic beverage use would be accessory to the principal use of the site as a tavern.

Upon review of the subject application, this Office finds that the proposed use meets the conditional use requirements for alcoholic beverage uses under Section 18-10-104 of the Code as well as the general requirements for alcoholic beverage licenses under 18-2-109. The applicant has provided an exhibit that shows the entertainment area more than 100 feet from nearby residential properties. Accordingly, this Office would have **no objection** to the issuance of the requested upgrade to the existing liquor license.

The applicant is advised that building permits and grading permits are required for all renovation and/or new construction. Additionally, a Zoning Certificate of Use is required for the subject use.
