LICENSE REQUESTED: NEW Class A (Beer, Wine, Liquor) (Off-Sale Only) Beer/Wine Tasting and Sunday License

This Office finds that the subject property is zoned C4 – Highway Commercial District. §18-5-102 of the Anne Arundel County Zoning Ordinance allows package goods stores as a conditional use in a C4 District.

Upon review of the subject application, this Office finds that the proposed use meets the conditional use requirements for package goods stores provided under §18-10-143 of the Code as well as the general provisions for alcoholic beverage licenses under 18-2-109. The applicant's exhibit shows the 1,000 foot radius from the proposed package goods store and does not show any schools or religious facilities within that radius. Accordingly, this Office would have **no objection** to the issuance of the requested liquor license.

The applicant is advised that building permits and grading permits are required for all renovation and/or new construction. Additionally, a Zoning Certificate of Use is required for the subject use.
