PROTEST OF LIQUOR LICENSE RENEWAL

Name of Licensed Establishment: The Magothy Inn

Address of Licensed Establishment: 546 Center St., Pasadena, MD 21122

In accordance with §4-406 of the Maryland Annotated Code, Alcoholic Beverages and Cannabis Article, and the Rules and Regulations of the Board of License Commissioners for Anne Arundel County, Chapter 2, § 2.09, the Protest of Renewal may be made by: procuring at least ten (10) signatories who are:

- A. Residents, commercial tenants who are not holders of or applicants for a license, or real estate owners; and
- B. located in the immediate vicinity of the licensed premises.

Protests must be based on specific complaints as to the operation of the establishment. By Law, a protest against the renewal of a license must be filed at least thirty (30) days before the license expires on April 30th. All protests must be received at the Board's office by 4:00 p.m., March 31st. Such protest of renewal hearing must take place during the month of April. At the hearing, it is necessary that the Protestants appear to substantiate the basis of their complaints.

Reason for the Protest/Comments:

The tavern has unlawfully expanded its service and operational footprint beyond the limits permitted under its non-conforming use status. This expansion means the licensee has repeatedly falsified renewal applications by omitting this information. The tavern is also violating county noise ordinances and liquor regulations by generating excessive, unnecessary, and disruptive noise, particularly after the 10 p.m. quiet hours, and by failing to adequately monitor or control such disturbances. Additional problems include public urination and vomiting, even on neighboring properties. Tavern staff have also repeatedly encouraged patrons to disturb nearby residents.
