In accordance with Sections 1-601, 1-602, and 1-603 of the Environment Article, <u>Annotated Code of Maryland</u>, the Maryland Department of the Environment, Solid Waste Program (MDE/SWP) is presently reviewing a Refuse Disposal Permit Application submitted by Anne Arundel County Department of Public Works for the proposed vertical expansion of the existing Cell 9 at the Millersville Landfill and Resource Recovery Facility located at 389 Burns Crossing Road, Severn, in Anne Arundel County, Maryland. The landfill is a non-hazardous solid waste acceptance facility that accepts residential waste, commercial waste, bulky waste, land clearing debris, scrap tires, construction and demolition debris, and recyclables.
